Packing materials	<p>Please use packages strong enough to avoid damage during transportation, unloading, unpacking, storage, reloading, etc...</p> <p>Packing in cartons is not considered suitable for repeated handling, especially for valuable or fragile equipment.</p> <p>Furthermore, parcels can be placed outdoors several times, before delivery inside exhibition halls, or after closing: exhibitors must take necessary precautions against damage and rain.</p>

Fumigation	<p>All cargo containing wood entering into EEC country (except coming from Switzerland) must have been fumigated in the country of origin.
